Selection criteria:

- All Level-8 overall skiers, plus the top 2 level-8 skiers in slalom, trick and jump from each qualifying age group.
 - Up to 4 discretionary spots for Girls-2 and Boys-2
 - Participation at Regionals or Nationals

Team members are invited to attend a three-day Western Region Best of the West Water Ski Development Camp. Team members are coached by professional, high-level coaches. Camps are being scheduled for June.

If space is available, alternates will be invited to the BotW camp.

Additional "area camps" are planned throughout the region and are open to all junior skiers.
